B-NADO TUE

- B-NADO recognizes that athletes, like all people, may have medical conditions or illnesses that require them to receive treatment with a particular medication or undergo medical procedures. If the substance or method prescribed to treat that medical condition is prohibited by the World Anti-Doping Agency (WADA) Prohibited List, athletes can apply for a Therapeutic Use Exemption (TUE), and if granted, obtain permission to use a prohibited substance or method in sport for a specified time period. All TUEs are evaluated according to the WADA International Standard for TUEs.
